

**Late Fee:** Overdue invoices are subject to a 10% compounded late fee per month.

**Cancellation:** 50% fee due if canceled within 48 hours. 100% if within 24 hours.

**Travel:** All travel expenses (visas, carnets, air, hotel, parking, tolls, etc.) are paid by production.

**Insurance:** Certificate of Insurance (C.O.I.) with General Liability and Rented Equipment Coverage must be issued by production listing VK Sound, Inc. as Additional Insured and Loss Payee.

**L&D:** Production assumes all responsibility for any loss or damaged items rented during the terms of the project. Production is responsible for paying any insurance deductibles if a claim is necessary to be filed.

**Meals:** A hot meal must be provided by or before 6 hours past call time. If working longer than 12 hours, a second meal must be provided by or before 6 hours from the end of the first meal. If production / client fails to provide a meal by or before the 6 hour mark, production will be subject to meal penalties at full hourly rate. A 30-minute meal break is considered "on the clock," while 1-hour is considered "off the clock."

**Copyrights:** Any works created by VK Sound, Inc. on behalf of Production Company / Client are considered "works for hire," until invoice for rendered services is paid in full.
